We refer to our letter dated November 18, 2024 wherein we had mentioned that as on November 14, 2024, the aggregate holding of the Schemes of HDFC Mutual Fund in "TCI Express Ltd." ("The Company") was 5.15% of the paid up equity share capital of the Company (Paid up Equity Share Capital being Rs. 7,67,60,040/- comprising 3,83,80,020 Equity Shares of Rs. 2/- each).
